

Terms and Conditions

Your participation in the Hot 100, Mix 104.9 and SecureNT Competition 2017 ('the Competition') constitutes deemed acceptance of the following terms and conditions:

1. By entering, you acknowledge that each entrant has an equal chance of winning the prize and SecureNT will draw the winner.
2. The Promoters of the Competition are Hot 100, Mix 104.9 and SecureNT.
3. SecureNT reserves the right, at any time, to verify the validity of entries and to disqualify any entrant who tampers with the entry process or who submits an entry that is not in accordance with these terms and conditions. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
